## ***DREAMS Come True*** **Guidelines**

- ***Minimum age: 55***
- ***U.S. Citizen or legal U.S. resident***
- ***Unable to fulfill the DREAM on your own***
- ***Capable of experiencing the DREAM***
- ***Granted to residents in the geographic area of:***
  - ***Green Valley***
  - ***Sahuarita***
  - ***Amado***
  - ***Arivaca***
  - ***Tubac***



## ***DREAMS Process***

1. Applicant and/or Nominator complete and submit the application form.
2. The *DREAMS Come True* Committee will evaluate the application to ensure it meets all criteria.
3. The Committee may conduct additional background checks.
4. If all criteria are met, a *DREAMS Come True* representative will call and interview the potential *DREAM* recipient and/or nominator.
5. If the application is not accepted at this time, a letter will be sent by the *DREAMS Come True* Committee.
6. *DREAMS Come True* recipient finalists will be provided a Waiver and Release Form to execute prior to the final selection, along with a Name and Photo Release Form. Receipt of these signed forms is required for *DREAM* fulfillment.
7. The *DREAMS Come True* Committee will make a final determination as to whether or not the *DREAM* will be fulfilled.
8. The *DREAMS Come True* Committee will notify the potential *DREAM* recipient and/or nominator regarding the *DREAM* timeframe and logistics.

The following applications for *DREAMS* will not be considered:

- Financial assistance/cash
- Housing assistance
- Home furnishings
- Technology purchases
- Medical treatment/services
- Legal services
- Vehicles/repair
- Assistance finding employment
- Funeral arrangements/posthumous requests
- Continuous *DREAMS*
- Reimbursements for completed *DREAMS*
- Travel *DREAMS* must be safe and realistic for the traveler and realistic for *DREAMS Come True* to fulfill
