

## Board of Trustees

La Posada's Board of Trustees is a volunteer group of individuals committed to the mission and values of La Posada and its role as a not-for-profit community organization. ### **SIMON DAVIS, Board Trustee**

Mr. Davis served as Green Valley Fire District Chief for 28 years. Davis lived with his family in Southern Africa until 1981, attended school in the United Kingdom, then came to Tucson to attend the University of Arizona and study mining engineering. While a student, Davis became a volunteer firefighter and found his new career. He started as a firefighter in Green Valley in 1987 and became the Fire Chief in 1996. He has spent extensive time working with his colleagues in emergency services to enhance safety and delivery of emergency care including internationally participating in conferences on pre-hospital emergency services. Davis is also the State President of the Arizona Fire District Association representing 140 Fire Districts supporting both elected officials and personnel.



### **PAULA DONLEY, Board Trustee**

Paula Donley is a principal at Donley Commercial real estate and is a resident of Oro Valley. From 2014 to 2016, Ms. Donley served as director of advancement at Pusch Ridge Christian Academy, responsible for financial aid and scholarships, budget development and management, and raising \$300,000 annually. From 2011 to 2014 she served as director of admissions and as a teacher at the academy. Ms. Donley was an academy school board member from 2001 to 2005. She was acting director of Women's Ministries at Catalina Foothills Church from 2010 to 2011 and director of Women's Bible Studies at the church from 2006 to 2009. Ms. Donley obtained a bachelor's degree in secondary education in 1976 and a master's degree in education in 1978, both from the University of Arizona.



### **RICHARD DUCOTE, Board Trustee**

Mr. Ducote interacted with many Green Valley/Sahuarita non-profits as Community Development Manager at Freeport McMoRan, from which he retired in June of 2015. He is an Arizona native, and a Tucson resident since 1966. He was a reporter for the Green Valley News from 1984 to 1986, and a longtime reporter, editor and columnist for the Arizona Daily Star. Mr. Ducote has served on the Board of Directors for several area organizations, including the American Red Cross Southern Chapter and the Community Performance & Art Center (CPAC) of Green Valley. Mr. Ducote holds a Bachelor of Arts degree with major in political science and minor in journalism from the University of Arizona.



### **VIC FRESOLONE, Board Trustee**

Mr. Fresolone has been a resident of Oro Valley since 2013 after retiring from being CEO/President of acute care hospitals in New Jersey and Oregon. In New Jersey he was with Union Hospital for twenty years, later merging that hospital into the RWJ Barnabas Health Care System. At Barnabas Healthcare he was Sr. VP for Mergers and Acquisitions. In Oregon, he spent ten years at Mercy Medical Center, and later invested three years at ATRIO Health Plans, a Medicare Advantage Plan. He was born and raised in Northern New Jersey and lived there until 1996, when he and his wife moved to Oregon. Mr. Fresolone has a degree from Seton Hall University in Business, and a graduate degree from Saint Louis University in Hospital Management. Over the years he has had several healthcare related articles published and has served on many community and civic boards.
