




Our Employees Are a Source of Renewal








2016 CAMPUS RESIDENT SATISFACTION SURVEY "My overall satisfaction with La Posada is"




2016 CAMPUS RESIDENT SATISFACTION SURVEY




Focus on Lifestyle

Happenings

La Posada is awarded 2016 Chamber of Commerce Not-for-Profit Business of the Year Award.

23 community centenarians honored at a celebration in the Community Center.

Los Niños del Valle's outdoor classroom is created and funded by gifts to the La Posada Foundation.

Connect app for the Green Valley/Sahuarita community is developed to complement the physical location and shared to promote information on available community services.

The Shoppes at La Posada held **numerous benefit walks and concerts** to support not-for-profit causes and businesses in the community.

Annual Volunteer Appreciation Event hosted to express gratitude to 202 off-campus volunteers for their hours of contribution, and to La Posada residents for their 56,575 hours of volunteerism, both on and off the La Posada campus. Together, all these hours were valued at \$1,743,000.

Commitment

La Posada has long been recognized for its commitment to maintaining its buildings and grounds through the last 30 years. We understand that it is not enough to continue new building, but we must give ongoing attention to image, resident expectations, changing market demands and safety.

We want to have a campus that always looks fresh and well-maintained, and that is staying abreast of changing technology opportunities to make life easier and safer. Also important is attention to the visual appeal and detail that provides the recognition that everything we touch is cared for. Financial stability is a strength of La Posada, and it is recognized in the retirement community field for this. In the long term, a second campus provides even more financial strength due to the ability to serve two diverse and distinct marketplaces and to share a portion of overhead expenses and spreading of risk.

So, even as we thrive with new programs, and sustain what we have done to the highest standards possible, we invest in growth as well.

La Posada has a 30-year history of growth... moving from its campus, to home and community services, to The Shoppes at La Posada, to "Connect" in a nearby shopping center, and now, to another nearby town with a second campus.









Financial Summary

La Posada's financial performance in 2016 followed the healthy pattern of recent years. Performance measures continued above average compared to continuing care peers as reported by accreditation and rating agencies. Financial well-being is essential for resident security and well-being, and makes it feasible to pursue more opportunities in the greater community. Many years of good financial health have improved the company's ability to pursue appropriate growth opportunities, to handle uncertainty, and to deal with an increasingly regulated and litigious business climate. A corporate parent, Posada Life, was formed as a 501(c)(3) in 2015 and the application for Federal Tax exemption as a supporting corporation was filed in December 2016.

The high acuity Assisted Living program

in La Hacienda that replaced Skilled Nursing beginning in January 2014 continued with good occupancy and financial numbers through 2016. Justification for that decision continues; residents are generally supportive and other communities have followed La Posada's lead. Long term care insurance coverage inflexibility regarding this change, especially with older policies, continues to be resolved favorably in most cases, case by case.

The self-insurance program for employee health benefits and wellness (CCHIP) completed a successful fifth year. Long term, this program is aimed at improving employee wellness, which translates into greater staff and resident satisfaction, plus potentially lower claims/premiums while enhancing the company's reputation as an employer of choice.

During 2016, work continued on the proposed second campus, Nakoma Sky, in Oro Valley, 40 miles to the porth of La

in Oro Valley, 40 miles to the north of La Posada. Contracts in force covered marketing, architecture, landscape design, interior design, pool design, civil engineering, pre-construction, financing feasibility and contract development. The project continued to gain approvals from Town agencies. The latest draft plan for the campus' first phase includes 217 apartments in connected 2, 3, 4, 5 story buildings, a 48 suite assisted living and memory care facility, infrastructure for town homes and free standing homes, plus key amenities. The costs associated with developing the new facility are to be reimbursed at financing, and are being funded in the interim by a \$10MM revolving line of credit from Northern Trust Bank. At year-end, \$7.8MM had been drawn. The bank also hosts

an escrow type account containing reservation deposits from 179 families at year-end, beating expectations and proof of an under-served market. Most of the Nakoma Sky expenses are being capitalized or treated as pre-paid marketing, in addition to another \$269,000 that is recorded in 2016 operating expenses.

La Posada touches a broad spectrum of age and income levels as reflected in these statistics for 2016.

• Independent living apartments and homes housed 716 people

• Assisted Living housed 185 people (95% came from campus)

• Outpatient Therapies treated 837 patients (89% from outside the campus)

• In addition to outpatient therapies, community outreach included 3,719 person days of adult care

- 8,010 senior lunches served
- 11,186 days of child care
- 425 behavioral health counseling sessions
- 4,535 encounters in Community Connect

• La Posada employed 835 people during the year, 626 on the last payroll

Monthly service fee increases for 2016 over 2015 were 2.2%. For 2017 over 2016 they will be

3.25% and 3.35% depending on location. The state voter approved minimum wage increase for 2017 has been accommodated in part by the rate increases and by reductions to some expenses. Management strategy is to hold resident rate increases down to help improve market penetration and ease pressure on current residents. Reserves are building at a slower rate, essentially flat the last two years and projected for 2017. Financial projections show performance still above average compared to accredited peers and rated non-profit continuing care retirement communities (CCRCs).

Outpatient Therap

All debt covenants with Northern Trust Bank were met or well exceeded for the year. The

debt service coverage ratio reported in the audit ended the year at 2.64, well above the 1.25 covenant. The debt covenant for margin value of bank holdings is \$16MM and at year end the actual value was \$24MM.

Management remains confident about the health and expansion of La Posada, all of which are true to the mission "To maximize the well-being of seniors." Management and the Board of Trustees remain committed to doing everything possible to meet the expectations of its creditors, to maintain satisfaction of residents, staff, and the larger community.

Mission

As a not-for-profit, growth is about expanding our mission to serve more people. This has been done through the years as we built out our 100+ acre campus to meet the needs of the communities around us.

La Posada merged in 2011 with Casa de Esperanza to embrace the ability to meet a larger sector of the population, primarily seniors, through Adult Day Services, counseling, community education and senior meals. The pre-school program provides a way to support the workforce that, in turn, provides care and services to Green Valley.


Next, La Posada extended itself to welcome the larger community to gather and enjoy its campus as a social and benefit concert spot where all can enjoy the lovely environment, experience the interaction that maintains vitality, and have the ability to view art and even purchase or consign that special something. Thus, The Shoppes at La Posada was created, and it has become an important and valued asset for the community at large.

Connect Community Services and Posada Life at Home were created next to further expand our reach to support those on and off campus with services they needed and wanted.

Perhaps the largest leap in expanding our mission to seniors is reflected by our Nakoma Sky community, under development in the Town of Oro Valley just 40 miles away. This venture has kept our ideas of how to provide for seniors fresh and evolving, better preparing us for the future. Once open, Nakoma Sky will not only provide for 375+ new residents, but will enhance the lives of La Posada residents by offering some reciprocal opportunities.

Posada Health, another important program, was brought to the campus to offer convenient primary care, as this was recognized as a challenge for many residents and employees.

Posada Life, our new parent company, was created in 2016 to recognize the need for a change in organizational structure as we expanded into community services and to a second site.



Commitment

Renewal - Every fall we approach the start of another annual giving campaign. It is that time we renew support for the many programs that enrich the lives of residents at La Posada. Whether it be the latest best-selling, page turner for the library, a new bench in a shady spot, enhancements for our wellness program, or support for resident artists, singers and performers, the opportunities to renew our kinship with humanity abound.

Sustainability - An endowment is the very essence of sustainability! The principle is invested and we only spend the earnings. That means that the endowment will exist indefinitely -- the gift that keeps on giving! Our first endowment at La Posada was the Kephart Unrestricted endowment named after our first board chair, Bill Kephart. As the name indicates, these funds have not been restricted and can be used as determined by management.

The Bredvold Fitness endowment supports various programs that encourage fitness on campus. The Bredvolds (Lloyd and Bernice) were the ultimate endowment donors, as they provided funds for programs they knew they would not live to see. Truly paying it forward.

The Bowers Scholarship endowment honors the founder of our scholarship program, Wendell Bowers. His driving force enabled the significant growth that has aided so many people to afford the high cost of education and professional advancement.



The Good Neighbor endowment helps residents who have outlived their financial resources sustain their life at La Posada rather than being uprooted to a lesser, low-cost housing option. In 2016, the Foundation's Good Neighbor Fund helped out to the tune of \$169,781.


The Posada Life Community Services endowment serves the needs of the community beyond the boundaries of La Posada.


project, and improvements await for The Shoppes. As always, philanthropy will play a significant role!






